From a Different Perspective

On, November 17th, Nazia Hossain, a practicing Muslim wife, mother, and student from Plano, talked about customs and celebrations enjoyed by her religion. She showed slides of some basic customs, headgear and greetings in general use. I was surprised to learn these celebrations are many and varied across countries. And women wearing a full face scarf covering all but the eyes (niqab), a full face and body covering (burka, burqa, burqah), only the headscarf (hijab), or others is a matter of personal preference. Gay McAlister allowed Nazia to demonstrate the correct placement of the headscarf.

Nazia told us about the fasting and feasting associated with Ramadan and their one other holiday. Pregnant mothers and children under 13 do not fast; the feasting can go for several days. She mentioned that Muslim women are not permitted to touch a man other than their husband in even a casual way such as a handshake. A palm to your heart is always proper if you are uncertain.

Many members asked questions and Nazia relaxed into her subject. She demonstrated the five praying positions ending with the kneeling one we find most familiar. And yes, she does pray five times per day – even at the mall. An app on her phone shows the direction so she can align herself properly. Jane Merz asked what is worn under the long dresses and if it was hot in our Texas

summers. Nazia said the material is lightweight and breathable. She usually wears shorts underneath in the summer. Elizabeth Smith wondered why the men may customarily wear short sleeved shirts while the women are covered. Nazia quipped that the women are more beautiful than their male counterparts and should be covered for modesty.

Nazia was grateful for the opportunity to speak to our club and open a much needed and important dialogue. She asked to be notified so she could participate in our philanthropic projects.

A History of Altrusa

What is now Altrusa International was founded in Nashville, TX in 1917, as the Altrusa Institute. There was a need to women's civic organizations at the time because so many women were going to work during WWI. Dr. Alfred Durham started organizing clubs throughout Nashville, Louisville, KY and Dayton, OH. When he moved on to Indianapolis, IN he met Mamie L. Bass. Mamie admired The Altrusa Institute, but having helped her brother in organizing a Rotary Chapter, she felt Altrusa could serve a higher purpose. The first Altrusa convention was held in June, 1918 where Mamie's vision became a reality; the Altrusa Institute became a classified service organization for women.
