The mission statement of Bead for Life is to create sustainable opportunities for women to lift themselves out of poverty by teaching them entrepreneurial skills. This nonprofit organization has been helping women in Uganda for over 12 years by empowering them to transform their lives. Making paper beads into jewelry has helped over 40,000 women start their own businesses and has enabled 98% of their children to go to school.

Our Altrusa club has been holding jewelry selling events since 2012. Including the sales from the jewelry event at our February 16<sup>th</sup> dinner meeting, our club has raised over \$3,960 for Ugandan women. This is proof that Altrusans can make a significant impact in lives of thousands of Ugandan women.

# Altrusa International News Service Hours Updates Jean Stuart

The International Board has approved continuation of the definitions for "Service Hours" as listed in the current Club Annual Report. An "action" is the key term to be applied to counting a service hour. In review:

<u>Community Service Hours:</u> service projects and activities sanctioned by Altrusa, as documented in a Club's minutes. (Include time spent in planning, reparation, execution and evaluation of fundraisers and service projects. ASTRA and New Club Building are service projects. Operating and internal fundraisers to fund the operating budget DO NOT qualify for service hours.)

Member Service Hours: time spent on Club, District or International operations, NOT including club meetings. Be sure to include activities such as production of newsletter or website, planning and execution of leadership/training workshops, serving as international representative at Conference, serving as delegate at conference/convention business meetings. Etc.

Other volunteer Service Hours: time donated by members to non-Altrusa organizations such as volunteer boards, hospitals, non-profit organizations. Be sure to include other volunteer work, for example in hospitals, schools, libraries, not-for-profit organizations and activities such as mentoring, tutoring, etc.
