They're Here!! The Ninjas Go To Work April 6th

This is the fourth year of the Kindness Action Ninja (KAN) initiative Altrusa International of Richardson. In 2015-16, we helped first responders; in 16-17 we helped battered women and children in the Rio Grand area, in 2017-18 senior citizens. But what to do this year? Inspiration came by way of a new member, Kathy Yates, who declared at her initiation she would love to participate in a project helping deployed troops. Tragically, she was taken by cancer just a few short months later. So, in remembrance of Kathy and to honor our service men and women, we are gathering items for care packages, assembling and shipping approximately 200 overseas. We Donations of many items to go in our care packages are have enlisted the aid of Chaplain Potter in the Office of Public being collected at Friends Place, where many of the cli-Affairs at the Joint Naval Air Station in Ft. Worth to provide ents are veterans or are families of veterans. addresses of deployed chaplains who are happy to distribute



the boxes all across the middle east. Chaplain Potter knows how much joy these boxes provide as he was deployed no less than 6 times. The day gift boxes arrive are the very best days!

Also, we received advice and counsel from an amazing woman in Ft. Worth, Colleen Canion. Colleen and her evergrowing, ever-changing band of wonderful volunteers have shipped over 1000 boxes to our troops since 2003. She adopts units and when that unit returns stateside, she gets a new unit contact's name. America owes her an immense debt of gratitude.

Richardson Altrusan Susan Fischer, a long-time resident and friend of our community, has knitted caps for our soldiers – 3000 personally since 9/11. Susan led a statewide knitting team that won an Americanism award from Texas for the 25,000 caps they sent overseas! Her caps will be included in many of our care packages as well.

Additional support for the project has been provided through a \$1500 grant from the Altrusa International Foundation, Inc. These monies will help defray packaging supplies and shipping costs - shipping alone is \$50 per box and our greatest hurdle. Other friends in the community have made significant contributions to this effort - Richardson Dentistry (200 toothbrushes, toothpaste, & floss), Penzeys Spices (1000 packets in 5 different flavors), and Occumed Plus, Inc. (significant monetary donation) were very generous. Indeed, members of our Altrusa Club have also been contributing items since October- batteries, pens, Sunday comics, toiletries, paperback books, condiments, snacks, etc.

All the boxes will be assembled on April 6, 2019 at Friends Place (located in Richardson) and taken to the DFW airport post office.



Also, as part of our KAN (Kindness Action Ninja) initiative, members will be putting together 200 kits for the Days for Girls organization - sustainable feminine hvgiene products for women world-wide. To date, they have given supplies and education to more than 640,000 women! Without this wonderful organization and our help, many girls would not be able to attend school for several days each month.





She is currently President of Altrusa International of SW Dallas County, Inc. She has served as Club Vice-President, Foundation Treasurer, Director, and active member on all service projects.


She volunteered as Communications Chair her first year (not aware of the submission date a few months later) and was delighted to have won 2nd place on her submission of the Club's Yearbook.

The Information and Simplification Task Forces

Information Task Force

Currently Altrusa International collects information through Club Annual Reports, Governor's Annual Report and the International Representative Reports, which are prepared by different people, have significant duplication, and collect information that is not used.

Objectives

- 1. Review information currently collected from each source and remove duplication and information that is not relevant to the strategic plan or necessary to effect efficient operations of Altrusa.
- 2. Review information required to assess progress on Altrusa's strategic plan and how this would be best collected.
- 3. Ascertain most effective method to collect, collate and report information (e.g. use of Survey Monkey).
- 4. Review how best to manage the Distinguished Club Awards program.

Simplification Task Force

In research conducted four years ago members were asked for feedback on Altrusa and one of the key themes that emerged from this was members desire to reduce red tape and simplify the requirements of membership, leadership and governance.

Objectives

- 1. Review bylaws and policies and develop recommendations to reduce complexity of our "rules" and the interpretation of them
- 2. Review club and district operations and liaise with Executive Director re Office operations with the aim of reducing "red tape".
- 3. Review Altrusa's leadership development process can this be streamlined?
- 4. Consider re-organization of International Policies grouping policies on similar areas together to make it easier.
- 5. Review for Gender neutral language.


